Automatic Giving from a Checking or Savings Account

FAQ (Frequently Asked Questions)

Is this complicated?

No. It's really very simple. Just complete the short authorization form on the top and give it to us... we'll do the rest!

It's the same process (Automated Clearing House - ACH) that employers use to make direct deposits to their employees' bank accounts and it's what many people use to automatically pay their utility bills each month.

Who is this giving option for?

Anyone who wants the convenience of automatic giving from his/her checking or savings account on a monthly or semimonthly basis. You may use this option to give your tithes and/or general offerings to the general fund and/or to give offerings to the building fund.

While giving in one of our worship services is the usual way that our members give, because of busy schedules, travel, or the built-in commitment of automatic giving, some donors like the convenience of having some of their giving automatically transferred from their checking or savings account.

Is there any cost (beyond my giving) for using this service? No, absolutely none.

Will my automatic giving be included on my year-end giving statement? Yes. It will appear on your giving statement the same as if you had given by cash or check in one of our services.

Can I cancel or change my automatic giving at any time?

Yes. You may cancel or change your giving at any time. However, we ask that you notify Fairfield Missionary Baptist Church office at least 10 days in advance of your scheduled donation date to allow time to process the change or cancellation.
